### **Court Victory Against Crime Network in EU Institution Offices led by EU Commissioner Didier Reynders with his partner Belgian Health Minister Frank Vandenbroucke**

Judges in Brussels have ordered a major court victory for Poland citizen Leszek Sachs, who successfully argued that he was illegally denied access to the Belgian health care system for nearly 3 years, by the Frank Vandenbroucke Health Ministry and its RIZIV-INAMI regulators, in a crime scheme led by EU Commissioner Didier Reynders.

Didier Reynders behaved as if enjoying and sharing significant bribery funds by supporting his friend Frank Vandenbroucke, engaged in apparent millions of health care funds fraud ('gesjoemel') as exposed in media by Het Laatste Nieuws.

This is the second major public bribery scandal for both EU Commissioner Didier Reynders and Frank Vandenbroucke.

The team of EU Commissioner Didier Reynders began leading the bribery-extortion scheme in early 2022, with **EU staffer Monika Mosshammer, a German working directly under Reynders, writing notorious lies about EU law** and about documents she had received, and in turn suborning EU Ombudsman staffer Tina Nilsson to publish the same lies about EU Law, in order to violate EU Court of Justice Court Order C-535/19, quoted below. Mosshammer and Nilsson behave as if they both received bribery funds in this.

Whereas as Mosshammer and Nilsson both knew, C-535/19 clearly states that EU member state national laws restricting national health system enrollment for EU citizens, are entirely illegal and invalid - direct words of EU judges quoted below - both Mosshammer and Nilsson published lies claiming that no such EU law exists, and that EU member states can do what they please about denying EU citizens access to health care and even cause their deaths from this denial.

Reynders' underling, now EU Justice Director-General, Ana Gallego Torres, also joined the criminal scheme, publishing the criminal lie that all was fine and ethical with the criminal statements of Mosshammer and the obvious conflict of interest in Reynders handling this dossier, with Reynders' own political party grouping being almost one-third of the Belgium government cabinet - Gallego Torres acting as if she was receiving bribery funds herself as well.

Reynders' German EU Commission underling Mosshammer, has not denied it was also her personal pleasure to commit racist hate offences against Polish and Jewish EU citizens, denying their crystal-clear EU Citizen Rights and seeking to cause their deaths as Nazis did in the 1940s.

In their court order against the criminals attacking him, Belgian judges ordered the immediate enrolment of Leszek Sachs in the CAAMI-HZIV health mutual, retroactive to his application dating back to 5 March 2021, and that the enrolment must be made even if the Vandenbroucke Health Ministry, encouraged by Reynders, appeals the orders against them.

Representing himself, and speaking in simple imperfect Dutch to panels of judges in Brussels courts, **Polish citizen Leszek Sachs defeated lawyers from multiple law firms, with the Vandenbroucke health ministry apparently spending tens of thousands of euros in legal fees to try to deny his EU citizen rights** to register in the Belgian health system, in what Sachs argued was an attempt by health ministry officials to obtain bribes from EU citizens in Belgium.

**Law professors in Belgium express puzzlement** why the Frank Vandenbroucke health ministry would spend tens of thousands of euros in public funds, trying to deny a legally registered EU citizen, his access to Belgian health care, given that EU law - EU Court of Justice Court Order C-535/19 - is so absolutely clear.

CJEU Court Order C-535/19 states that, intrinsic to the EU Citizen right of 'Freedom of Movement', every EU citizen legally registered in an EU country - including those 'not economically active' such as pensioners, non-working spouses or partners, or self-supporting individuals - have immediate right to join the EU national health system where they are resident, when no other EU-approved system covers them. Any national laws or regulations blocking this health care system enrolment, are entirely illegal.

Court records show an e-mail from a Frank Vandenbroucke assistant, presenting himself as a personal consultant to help Leszek Sachs have his rights, in what appears to have been an attempt to obtain a bribe. **Leszek Sachs has been urging Belgian prosecutors to conduct an investigation into RIZIV-INAMI files**, and the pattern of possibly illegal discrimination and delays and systematic violations of EU law, as part of an **effort to obtain bribes from EU citizens**, as there may have been multiple victims dead or dying from illegal denial of health care by the Belgian Frank Vandenbroucke Health Ministry, and the EU Commission crime network led by Didier Reynders.

**EU Court Order C-535/19**, exact words of the EU Court:

**"A Member State cannot, under its national legislation, refuse to affiliate to its public sickness insurance scheme a [European] Union citizen.**

**"The Court confirms the right of economically inactive Union citizens residing in a Member State other than their Member State of origin to be affiliated to the public sickness insurance system of the host Member State in order to obtain medical care financed by that State.**

**"The Court notes that Member States, are under an obligation to comply with the provisions of EU law ... they cannot determine to what extent their own legislation or that of another Member State is applicable."**
