**EU Court Statement on EC Reynders crime group; Sec-Gen formal notice**

To especially Secretary-General Ilze Juhansone - to whom this letter is the technical 'final appeal' **demanding that the EC cease its crimes and unlawful practices, before the EU Court of Justice intervenes** -

And to all EU Commission, EU Ombudsman, and OLAF staff implicated in the Reynders et al. crime affair -

Recently I have been in communication with Judges at the European Court of Justice in Luxembourg, about the serious violations of EU Law now being run out of EC offices, in the crime scheme involving Commissioner Didier Reynders, Belgium, and the **shocking abuse and denial of core human rights of EU citizens in violation of EU Court Order C-535/19**.

And I have received a **letter written by the European Court - attached** - shaming the criminal lies which no less than six of you have addressed to me, and for which some of you may go to prison in 2025 after current EU & Belgian regimes are gone.

Some of you perhaps did not realise, that **under EU Law**, when the EU Commission causes major damages to EU citizens by not enforcing EU Law - and even more, when EU Commission staff are committing criminal acts against EU citizens, as in this case - I am able to file at the ECJ personally as an EU Citizen against the EU Commission, and collect **appropriate damages and compensation from the EU** for all I have suffered.

Ursula von der Leyen's top ECJ lawyer is aware of all this - first in cc line above - and Ms Juhansone, you should very definitely have his counsel, before you make a stupid statement to me that could send you to prison.

**Six of you have already written criminally false, lying e-mails**, serving the goal of denial of rights and attempted murder of a witness before European courts ... attempted murder which is also an implicit terror threat against the ECJ judges whose historic Court Order you are so brutally violating.

**ECJ Judges are quite proud of their historic human-rights-protecting Court Order C-535/19 of 15 July 2021, which confirm absolute INVIOLEABLE national health care system access for ALL EU CITIZENS in ANY EU country where they reside**, whenever no other EU system - such as your EU personnel health system - covers them.

Defiling the law, proving their own criminality, the six EU Institution staffers who wrote lies to me about the violations of Rule of Law by Didier Reynders' friends in Belgium, and related misconduct by EU staff, **all quite refused to discuss Court Order C-535/19**, and the proof the EC holds that Belgium is violating this core EU Law on the Rights of EU Citizens.

Has there ever been a greater crime committed by EU Institution staff members, than these crimes against myself?

Do the stupid six EC staff criminals who wrote criminally false communications to me, not realise that you are not only mocking and seeking to torment the victim you are seeking to murder, but **you are also spitting in the face of the ECJ Judges themselves?**

How do you think the ECJ Judges will rule, as they continue to review all these psychopathic, dishonest, malevolent communications you have all sent to me?

The six lying persons at the EU, guilty of criminal activity against me: Ana Gallego and Monika Mosshammer in Reynders' DG; Tina Nilsson and Rosita Hickey at the EU Ombudsman; Ville Itälä of OLAF; and Christian Linder at the EU Secretariat.

And for Tina Nilsson, the biggest criminal liar of the whole group ... Swedish University law faculties are already becoming aware of your crimes, how you betrayed the whole Swedish tradition of the Ombudsman as well as tried to murder a Polish-Jewish citizen, joining with racist hate crimes of others.

There is now a French citizen identified to me, who has also been targeted by Didier Reynders' bribery-extortion friends in Belgium. So crime operations are proceeding exactly as Reynders wished, seeking to violate the EU Citizen Rights of many others, helping Belgian ministers to earn bribes, either from the victims, or kickback-bribes from dishonest lawyers receiving many thousands of euros defrauded from Belgian taxpayers, to harass victims and delay their EU Citizen Rights for years in slow Belgian courts.

You all know how this works from the **28-page dossier on Rule of Law violations by Belgium**, which I filed in October with Věra Jourová, Ms Jourová blocked by Von der Leyen from replying to me.

Ms Juhansone, your subordinate Christian Linder, is clearly confident that you also will become a lying prostitute for criminal activity by Von der Leyen and Reynders, just like himself.

But as a Latvian, Ms Juhansone, you should be particularly aware of Court Order C-535/19 as that is an EU Court decision originating in a case in Latvia. It is a wonderful, beautiful, historic Court Order, very simple and clear ... underscoring what a major crime it is, for the Reynders crime group at the Commission to be violating it.

Excerpted from the European Court brief attached, the **Court's exact words** ... showing what a bunch of criminal liars are the six EU staffers named above:

**"The Court confirms the right of economically inactive Union citizens residing in a Member State other than their Member State of origin to be affiliated to the public sickness insurance system of the host Member State**

**Member States are under an obligation to comply with the provisions of EU law in force ... Member States, they cannot determine to what extent their own legislation or that of another Member State is applicable**

**Accordingly, a Member State cannot, under its national legislation, refuse to affiliate to its public sickness insurance scheme a Union citizen"**

Although the six people writing lies to me all show some stupidity, none of you are stupid enough that you do not understand this ECJ Court Order and its importance, and the proof you hold of Didier Reynders' criminal friends in Belgian government violating this order.

Of course if you have any questions, Health Commissioner Kyriakides can explain it to you ... tho she too is under duress from Von der Leyen to keep her mouth shut. A top EU Legal Service Health lawyer is the 2nd name in the cc line and he can also counsel you on ECJ Court Order C-535/19.

Ms Juhansone, I have no illusions of the likelihood you will do what is professional and correct here, rather than just become the 7th person at the EU to send me yet another amazingly stupid and criminal communication serving crimes of Von der Leyen and Reynders, another bogus note once again refusing to confront C-535/19 and its violation.

But for the record:

- I **demand here that the EC reverse its previous course of corrupt collaboration** with violations of EU Law and EU Citizen Rights in Belgium;
- and I **demand that you immediately compel Belgium to respect EU Court Order C-535/19** in my case, in the case of the French victim, and in the case of all other victims past and present;
- and I **demand that you present an offer of just and fair compensation, for the mauling of my life, and the abuse I have suffered from an entire string of EU staff sptting criminal lies** into my face for over a year now ... doing this because they have no ethics aside from seeking to please Von der Leyen and Reynders, and seeking to perversely enjoy damage to other people's lives when they think they can get away with it.
