Belgian Court, Reynders bribery, extortion, attempted murder

Hello Head of Cabinet Soewarta, Commissioner Vestager, and Competition Team,

You deserve to know that in Belgium there is a court filing formally charging Didier Reynders as a criminal co-leading bribery extortion crimes with his Belgian government friends, over EU citizen rights to health care, and the attempted terrorist murder of witnesses who are providing information to law enforcement.

This case is now also an open criminal investigation file by the Brussels regional criminal prosecutor, Dossier no BR 23BC41871.

This of course is the second public bribery scandal for Reynders. My condolences to you if this evil dangerous man becomes for a time your Commissioner, before court actions force his resignation. My suggestion is not to participate in criminal acts with him when Reynders asks you to do so, regardless of the size of the bribes you are offered.

The Belgian court file detailing the criminal scheme is linked further below. It is in Dutch. You may find it easier to quickly read the summary presented in English to the judges at the EU Court of Justice, quite shocked to learn of the corruption in EU Commission and Ombudsman offices, the Court having very kindly given me a private reply.

You know that the EU Court has ordered universal national health system access within the EU for all EU citizens, if no other EU system covers them, EU Court Order C-535/19. It is crystal clear. Health system access is inviolable part of 'freedom of movement', and any national laws or regulations blocking this access are illegal under law, even if people are without jobs, pensioners etc.

Reynders and his friends run a scheme in Belgium of targeting certain EU citizens for bribes before they are allowed to have health care, using the weapon of ultra-slow Belgian courts. The bribes are cheaper than legal fees over many years. If people are too poor to pay, Reynders and his friends try to murder people by denying them health care. Belgium gov then hires low-life lawyers to present lies in court and delay EU Citizen Rights for many years ... the lawyers' fees then become an alternate source of bribery funds for Reynders and his friends.

Von der Leyen supports the crime scheme, in a visible EU-Belgium corruption exchange. You likely know Von der Leyen has her husband in the covid vaccine business ... and is linked to armaments companies earning profits from killing tens of thousands of Ukrainians, who are sent to hopeless deaths with nearly no training for combat. Belgium doesn't prosecute crimes by Von der Leyen ... Von der Leyen allows Belgium gov to engage in bribery, extortion and terrorist attempts at murder, Belgium the worst 'rule of law' violator in the EU.

The NATO intelligence agencies recently learned about these crimes, and how the murderous, nasty Von der Leyen is far too corrupt to take the NATO job after leaving the Commission ... her public career will be over shortly

With some combination of bribes & intimidation, Von der Leyen has corrupted all 4 of the EU's ethics / prosecution bodies. Prosecutor files show criminally corrupt communications from 8 EU Institution individuals about these crimes, some of them writing the most absolutely inane stupid lies about EU law in order to serve the crime scheme:

- EU Legal Service Director Daniel Calleja Crespo
- Reynders' staffers Monika Mosshammer & Ana Gallego
- Tina Nilsson & Rosita Hickey at the EU Ombudsman
- Christian Linder in the EU Ethics Secretariat
- Ville Itälä of OLAF and Laura Kövesi of the EPPO, who both send anonymous unsigned e-mails claiming their offices have 'no jurisdiction' over bribery-extortion-attempted murder schemes run out of EU offices

All of the above totally refuse to enter into any discussion of EU Court Order C-535/19 and the proof they all hold that Belgium and the EU are violating it. The biggest liars in the group are Mosshammer in Reynders' DG, and Nilsson at the EU Ombudsman, who both wrote enormously stupid criminal lies on EU letterhead. French prosecutors will soon be on the case of the utterly corrupt EU Ombudsman operation in Strasbourg.

And of course in addition to the above, there are five EU supervisors of these crimes who don't sign anything themselves but who have massive roles in criminal guilt - Von der Leyen, Reynders, Ilze Juhansone of the Secretariat, Emily O'Reilly of the Ombudsman, and Rule of Law Commissioner Věra Jourová.

Significantly, there are lot more people at EU Institutions writing criminal lies in this bribery extortion scheme, than in the Belgian government itself. Under EU law the EU must pay damages for the denial of health care rights and these attempts to murder people, and more legal actions are upcoming against Reynders and his friends.

The EU top Commission lawyer, Calleja-Crespo, doesn't even try to defend the criminals Reynders and Von der Leyen, aside from crassly e-mailing criminally libellous insults. Calleja-Crespo is rather instead encouraging legal actions against the Commission. He issues EU contracts to outside lawyers and then can likely get some nice fat bribes out of the hundreds of thousands in legal fees he gifts to his friends at the law firms.

Here's the Belgian court filing detailing how the whole crime scheme works, including the 13 different lies used by the Reynders crime gang in their bribery extortion scheme, and how they try to murder people who don't pay:
