**Re: Terrorist threat by Belgians to murder US Citizen & former DOJ Employee, victor in Brussels courts against Belgium-EU bribery extortion**

**Large-scale damage to US Companies & Citizens from EU Commission bribery networks**

**EU money-laundering sponsorship of terrorism which may kill Americans, to distract from EU & Belgian officials defrauding millions of public funds**

Your Excellency, colleagues of the FBI / CIA:

You will be concerned about crimes - well known to Belgian police - of Belgian officials threatening to murder a US Citizen and award-winning former US Justice Department employee, after he began winning in court against Belgium-EU bribery networks -

But this matter is much bigger than that, involving billions of losses and enduring harm to US companies via the current EU Commission bribery culture, and also an ongoing threat to murder other Americans, by the way that the EU and Belgium sponsor terrorist acts by extremists, as a distraction from the Western Europeans defrauding millions of public funds.

Tho you may not be acting on this until after my old friend Donald Trump is back in office after January 20, this dossier is presented to you so that you can act sooner, and so those continuing in office at the FBI have the information at hand. Incoming Vice President J D Vance has already spoken publicly about the need for a strong response to Europeans who viciously attack Americans, and this file will greatly assist.

To try to put it all briefly: I was born a USA-Polish dual citizen, and attended Harvard alongside Supreme Court Chief Justice Roberts. In youth I was an award-winning DOJ employee and then became a nationally known USA anti-corruption author. Since 2017 I have had a strong relationship with President Trump and his lawyers. In 2018, the 28-page DOJ dossier I gave to incoming Attorney General Bill Barr, helped his decision to wind-down the Mueller attacks on Trump; Trump tweeted about me.

Living in Brussels now since 2006, I was often in EU Commission offices assisting matters, with 'insider' info on the massive corruption that began there in 2020, corruption fuelled by Ursula von der Leyen's bribery of the De Croo Belgian government, Belgium having jurisdiction over EU offices. There has always been some corruption here, but Brussels Bribery City is now a murderous threat to the USA and Americans and American companies in Europe. There are satchels of tax-evading bribery and terrorism cash everywhere here now.

Early in 2021 attacks on me began by these bribery squads, who decided I was a 'rich American Jew' with 'secret Jew money', and they sought to extort a €5000 cash bribe from me to keep my place in the Belgian healthcare system, totally violating my EU Citizen rights, even demanding bribes by e-mail. After both publicly exposing these crimes, and winning against these gangs in courts here - 3 courts on my side now - Belgian officials now directly threaten to murder me.

## Terrorist threats by Belgians against US Citizen former DOJ staff; crimes against US companies p. 2

The two Belgian officials in public police records as menacing to murder me if I do not leave Europe, are in the bribery-filled Brussels 'parket' or 'parquet' (public prosecutor office), by name Gilles François directly making the threats, and his boss directing him, Tim De Wolf. They act explicitly on behalf of what they proudly call their 'mafia', with Belgian Health Minister Frank Vandenbroucke and Belgian Justice Minister Paul Van Tigchelt, both hip-deep in bribery and extortion crimes, this the 2nd major bribery scandal for murder-linked F. Vandenbroucke.

The chain of crimes here: Belgian Health Minister Vandenbroucke allows his lower employees to extort bribes, so they keep quiet about his fraud of millions of covid vaccine and other funds ... in which he is a partner of Heiko von der Leyen, covid vaccine executive husband of Ursula von der Leyen. Millions of covid vaccine funds and Ukraine war profiteering bribery funds, are shared with Belgian ministers so that Belgium blocks prosecution of criminals in EU offices. The 4 EU ethics / prosecution bodies are all neutered, through a combination of bribery funds and intimidation, with Ursula credibly bragging she has friends who can kill people.

Notably, with police reports of their threats to kill me online, and being publicly named by my supporters as terrorist extortionists on Twitter X, these criminals François and De Wolf do not even try to deny their crimes, knowing that every lie they tell is a new crime committed.

Factually 'terrorists' because they menace violence to preserve the political power of their bribery cabal, these men enjoy threatening to kill an American and assassinate a former US Justice Dept employee, because this lets them feel more powerful than America itself. Not to mention their joy in menacing to kill a Jew, and various other '2nd class' outsiders generally.

The credibility of the threats to kill me, is in the extensive contacts these terrorists have with the organised crime and drug gang underworld in Belgium. My murder can be hired in trade for the non-prosecution of crimes by gang members, aside from the bribery cash De Wolf and François can deploy, cash from Belgian ministers and the Von der Leyen EU.

There are forces and powers on my side, as well as the powers behind these terrorists. I already have 3 courts on my side, two in Brussels and also the EU Court in Luxembourg, which issued a sharp condemnation of Von der Leyen before her appointment to a 2nd term as EU Commission chief, which she takes as a license to continue in fraud, bribery and murder.

Also on my side is the courageous King Philippe / Filip of Belgium, who wrote a letter on my behalf; the Belgium Federal Ombudsman, whom Belgian criminals refuse to answer, and many in the Belgian police. The Belgian Federal Police and its anti-corruption squad on Koningstraat in Brussels, know all the crimes against me, but are forbidden to act by the corrupt Belgian federal ministers and 'Parketten' (prosecutors), the police have their hands tied.

Also on my side are courageous whistle-blowing civil servants within both the EU Commission - some of them knowing me for more than a decade - and within Belgian government, its Health Ministry and prosecution offices. Many civil servants are brave and try to help victims, but the problem now is that the EU Commission and Belgium both have such corrupt leadership, the honest employees are terrorised. I am the public voice for all of these people, and supported as well by citizens in Belgium and across Europe.

The way that all these crimes of terrorism and millions of corruption funds operate, is not well understood by Americans; the West European corruption style is distinctive. This is important background for all the US companies being attacked by corrupt EU 'regulators'.

Despite there being much corruption inside the USA, I never saw or heard of a similar pattern of lower-level USA civil servants making a sport of bribe-seeking against common poor citizens, for their basic human and administrative rights. Yet this is the case in both Belgium and the European Commission - absolutely no respect for law at all, and no one they fear looking over their shoulder, in the way that US civil servants would fear federal indictments.

The corruption genius of the criminal Von der Leyen, was that all crimes would be possible for her, if she included top Belgian ministers and prosecutors in her bribery umbrella, given that Belgium is the 'EU police force'. Von der Leyen can brush aside the tiny offices of EU prosecutors with a simple *plata o plomo* threat - she has 'friends in NATO' who can leave victims 'shot like Slovak Prime Minister Fico on the street', if they try to say anything against crimes of which they have evidence. Ursula orders EU staff that 'everyone help my Belgian friends'. Complaints about violations of EU law in Belgium, were long illegally shunted for 'handling' by Belgian EU Commissioner and bribery-scandal veteran Didier Reynders. As pressure increases on Von der Leyen, Reynders was recently fired as lined-up scapegoat for Ursula's crimes with Belgium. Reynders has been publicly challenged over this meme that helped spark his dismissal, and didn't deny it was accurate:

### WHY I SUCCEED AS EU BRIBE & CORRUPTION QUEEN

Do you know I do corruption trade with little Belgium government piglets, I help their crimes, and they block investigation of mine?

Do you know Brussels prosecutor piglets, directly threaten to murder witnesses, who make court filings about me?

- My crimes for my husband, covid vaccine executive Heiko von der Leyen, how I worked to make him richer - ha ha!

- My war crimes with Ukraine profiteering, thousands of Ukrainians sent to die with almost no training, many Slavs dead, my friends richer - ha ha!

I AM POWERFUL GERMAN WOMAN - NO ONE SHOULD QUESTION ME!

Another key aspect of EU corruption is the huge role in money-laundering and bribery played by armies of corrupt lawyers living off EU and Belgium government grift. Legal cases and damages work quite differently in EU and Belgian courts than in the USA, and often it is difficult, or practically impossible, for a damaged party to recover the costs of legal actions.

The biggest wicked game of money-laundering, is that both the EU Commission and Belgian civil servants, repeatedly violate EU laws on purpose, specifically to create long legal cases they know they will lose eventually ... but from which they profit, by virtue of the 'government' law firms 'rebating' some of the profits from 'legal fees', in tax-evading cash bribes to civil servants, whether at the EU Commission or at Belgian ministries. Law firms are encouraged to bill huge invoices for very little actual 'legal' work, they pay taxes on what they receive, and remaining profit of this laundered money is kept partly by the lawyers, partly by the civil servants. It seems as well that EU law firms hired by American companies, also give cash 'rebates' to EU Commission staff, to 'thank them' for creating the profitable 'problems' US firms pay for!

So in some of these cases where it seems the EU Commission is being 'ideological' or stupid-crazy, it is just that they want to start legal cases with rich American companies. The EU will hire law firms to 'defend', get paid fat invoices, and then the lawyers supply cash 'gifts' to EU Commissioners and top staff after funds are laundered in this way; Americans cheated bigly.

This money-laundering is also an aspect of Belgium's demanding bribes for EU citizens to have their health care rights, the topic in which I defeated Belgium in court. Under crystal-clear EU Law - EU Court Order C-535/19 - every EU citizen legally registered in any EU member country, has absolute right to enroll in that country's national health system, when no other EU-approved system (such as the separate system for EU employees) covers them. This very explicitly includes people with no job, but who have some other means of support (girlfriend or boyfriend of a local resident, pensioner or investor, etc.)

But Belgium violates this law over and over again to generate bribes, in two ways, one via direct cash bribes from richer people, the other via money-laundering by lawyers. For rich people, the €5000 cash bribe - sometimes 'negotiated' down to €3000 or €3500 - is cheaper than legal fees for several years, cheaper than private health insurance, and settles the matter quickly.

For poor people who try to fight to get their rights, as I did - the Belgians openly admit that, 'Yeah, you can win in court ... but you might die from lack of health care till you win in our slow courts, and we'll get our €5000 bribe and maybe more, from the lawyers we hire to attack you.' There were 10 Belgian law firms hired in the long course of attacking me, with the Belgian taxpayers defrauded of a likely €50,000 in the process ... and the Belgian civil servants and ministers getting their bribes as rebate from the money-laundered lawyer fees paid.

Another aspect pervading all this is that the EU (and Belgium) are quite extremely 'racist' in some fairly complex ways not well understood, including some 'intra-white' racism against fellow EU members. Ursula von der Leyen herself, with her Nazi-allied father, has inherited some of the classic 'Third Reich' style racialism - 'I am powerful German woman!'

Overall, the Western and Northern Europeans, the more 'Germanic-Celtic', feel they are the 'top class'. Americans and Jews are looked at as wealthy but second-class, somewhat stupid, as cows who can be milked, no match for clever old-world north-west white Europe corruption networks. These 'core EU' north-west Europeans, hold in contempt everyone east of Germany, Ursula herself sneers at the hundreds of thousands of 'second class Slavs' dying in Ukraine with

little or no training, so Ursula's war industry friends can make money. Mediterraneans such as Italians are also typically viewed as 'second class' by EU elites. Ursula also has sold the very-female EU Commission on how 'EU women' are free to engage in all sorts of bribery, corruption and murder, but can't be questioned because 'We are EU WOMEN.'

There is increasing news of crime and terror and quasi-terror acts in Brussels, and Belgian civil servants report that this is specifically sponsored and encouraged, and also highlighted in media, as a distraction from corruption, and from how racist Belgians and north-western Europeans are grifting millions in corruption cash. Belgium and the Von der Leyen EU Commission need to be monitored as possible sources of funding and incitement for near-future terrorist-type events attacking Americans, Jews, and others.

On 20 January 2025, I come under protection of the government of Donald Trump once again, and I also stand now as a key figure to help realise J D Vance's goal, of strongly responding to biased EU attacks on Americans and American companies.

Clearly the two Brussels 'Parket' officials who directly menaced to murder me, Gilles François and Tim De Wolf, need to be arrested by the FBI on terrorism charges if they enter the USA. They merit a US federal indictment and possible extradition request to the new Belgian government (still delayed in formation). With its officials menacing to kill me, Belgium should be regarded as a 'terrorist state' until its government is re-poised to address the horrific crimes that happened to me, as well as other similar victims.

And every USA company doing business in Europe and subject to EU regulation, needs to be informed of what is in this file, as they face the Von-der-Leyen-led EU bribery machine. This letter is published on the web, these are public facts, so share as widely as you like.
