

Summary - Corruption Exchange between Von der Leyen EU Commission & Belgium gov't

Von der Leyen EU Commission more corrupt than that of Jacques Santer in 1990s

Bribery-extortion and corruption exchange with Belgium to block VDL prosecution

Von der Leyen husband in covid vaccine business, VDL profiteering from Ukraine war

Extorting bribes from EU citizens over access to health care in EU countries

History recalls the massive corruption of the Jacques Santer era. Well, it is worse than that now. And I am one of the key witnesses in EU courts, exposing the crimes which are going on.

The EU judges in Luxembourg are so shocked at the violations of EU law and EU Court Orders by Von der Leyen (VDL) and friends in the EU and in Belgium, the higher EU Court honoured me with a private communication. Also supporting me is the brave King Philippe of Belgium.

And I am an EU 'insider', with friends inside the EU Commission for more than 15 years now, friends who are now under terror by the Von der Leyen mafia, with bribery cash all around for Von der Leyen 'friends', plus threats that her 'NATO friends' can 'do bad things' to anyone not co-operating or trying to blow the whistle.

Von der Leyen has been in corruption her whole life, this is partly in the public record. One source of bribery cash is her husband Heiko Von der Leyen who is in the covid vaccine business, linking with Pfizer etc. Another cash source is Von der Leyen continuing her corrupt links to the armaments industry she made as German Defence Minister.

Two key figures close to VDL's crimes - Belgian EU 'Commissioner for Justice' (ha!) Didier Reynders, and Belgian Health Minister Frank Vandenbroucke, partner with Heiko Von der Leyen in vaccines - are now both in their 2nd major public bribery scandal. You may remember Vandenbroucke from being in the Agusta-Dassault 1990s bribery scandal, linking in turn to the assassination of politician André Cools ... a murder which is used by the current Belgium De Croo government, to terrorise journalists here. 'Keep your mouth shut about Belgian corruption, or you can end up dead like Cools!'

The special 'talent' of Von der Leyen, was to buy, bribe off or intimidate anyone who has the power to investigate or prosecute her. So she has a full-fledged 'corruption exchange agreement' with Belgium, which has criminal jurisdiction over EU offices here. With Von der Leyen's encouragement, and stern orders to VDL staff to assist crimes here, Belgium has become the most corrupt country in the EU, the biggest 'rule of law' violator, openly asking for bribes from EU citizens - in writing by e-mail! - in order to have their EU citizen rights, such as enrolling in the Belgian health care system. This latter is what particularly shocked the judges at the EU Court of Justice in Luxembourg.

And in exchange for allowing Belgian Ministers to operate bribery-extortion schemes violating EU Law, Belgium blocks and impedes inquiry into all offences Von der Leyen commits, such as abusing her office to enrich her husband Heiko in the vaccine business.

Moreover, Von der Leyen swept through all four of the EU Commission's ethics and prosecution bodies - the EU Ombudsman, the EU Ethics Secretariat, the OLAF anti-fraud prosecutor, and the EPPO prosecutor - and suborned them into her criminal scheme. VDL has the same modus as South American drug dealers - 'plata o plomo', silver or lead, the bribe or

the threat of a bullet. Her links to NATO and its intel agencies - plus how her friend F. Vandenbroucke links to the killing of André Cools in Belgium - give her threats credibility.

And there are many EU top staff now, people with no moral anchor, simply eager to assist in unbridled corruption. Von der Leyen orders that all complaints about Belgium be handled by Belgian Commissioner Didier Reynders, of the same party group as 1/3 of the current Belgian government. Reynders' top assistant is Von der Leyen's 'German sister', Monika Mosshammer. And the biggest lies supporting crimes of Von der Leyen, come from the EU Ombudsman's office of Irish Emily O'Reilly and her Swedish top assistant Tina Nilsson.

The top lawyer at the EU Commission, Spanish Daniel Calleja-Crespo, mocks and insults victims and doesn't deny the crimes, encouraging victims to file lawsuits against the EU Commission at either the EU Court of Human Rights or the second 'general' EU court in Luxembourg which is opened to private individuals. Calleja-Crespo gives out lush 'legal contracts' to private law firms, and apparently can get nice 'kickback bribes' from this.

In the particular bribery-extortion scheme that targeted me, Belgium violates EU Court Order C-535-19, mandating universal access for EU citizens to the national system where they live, if no other EU system covers them, even if they are without jobs, e.g., pensioners, living in with a partner, independently wealthy etc. The weapon Belgium uses is that Belgian courts are slow, cases taking 10 years etc ... so richer people just pay the bribes, cheaper than lawyers.

For poor victims, Belgium diverts health care funds including EU covid funds to gangster law firms, who profit hugely from the long court cases, and the 'law firm contracts' then become the alternative bribe source for Belgian and EU officials. I introduced the matter to EU judges with this letter here, to which they very kindly replied, encouraging my fight against evil:

There's a very dark side to the war profits. Von der Leyen admits that Ukrainians are sent to near-certain death without training, just to enrich 'her friends', and 'who cares about dead 2nd class Slavs'. And she also admits that Russia has 'some rights' because of the Kosovo case in the Hague courts, which endorsed how rebel regions (such as Donbass) have a right to rebel, and to seek foreign help ... so everyone at the EU is ordered to 'shut up' about Kosovo.

On 16 October, I successfully exposed these crimes before 3 judges in a Belgian court, and I am going to the EU level shortly. My young friends are on X-Twitter **@TribunusBru** with material about these crimes and events.
