Dear Sweden Prosecutors, Ministers, and Government, now supervising the EU,

Firstly, I ask that you bring the full force of Swedish justice against the racist and terrorist Swedish civil servant Tina Nilsson, the propaganda leader of a bribery extortion gang seeking to murder multiple people if they do not pay bribes to her friends. Although some of Nilsson's criminal terrorist acts were carried out in other EU countries, it is highly likely that Nilsson carried out some of these crimes via electronic communications whilst she was in Sweden. I formally ask for the protection of Sweden against Tina Nilsson's efforts to murder me,

Secondly - doubtless the most difficult challenge you have faced in the Swedish EU Presidency - I ask that you have the courage to confront the Von der Leyen - Reynders German-Belgian mafia crime network, which is now drowning the European Commission in corruption and bribery cash, openly seeking to murder people, and which may also possibly be the cause of tens or hundreds of thousands of additional dead in Ukraine.

There is an implicit threat here to murder Swedish officials if you do not keep your mouth shut, as the Czechs did when they learned of these ongoing crimes in EU Commission offices. The Czechs and EU Commissioner Věra Jourová, thought it better to allow some people to be killed, rather than disturb their relationship to very powerful Germans, who are able to boast of being backed by NATO and its intelligence services in menace of murder. The criminal Tina Nilsson, already engaged in attempted murder, won't hesitate to see if her friends can help put a knife into the belly of a Swedish official just as happened to Anna Lindh in 2003.

Will try to be brief in this initial letter to you, though providing links to some of the extensive international files on these crimes, and writings from the murderous criminals including the Swedish civil servant Tina Nilsson, who is working directly as a terrorist agent of Ursula von der Leyen and Didier Reynders, along with her boss Emily O'Reilly. These crimes are technically 'terrorism' under the international definition, as they seek the murder of victims in order to maintain the political power of a particular group, the German-Belgian EU mafia.

The EU Commission and Belgium government, jointly run a bribery extortion practice against EU citizens, demanding bribes from some EU citizens before they can enjoy their EU citizen rights to health care system access, a right above all enshrined in EU Court of Justice Order C-535/19 of 15 July 2021, about which more below.

The EU-Belgian bribery extortion scheme seems to target primarily richer people, with the bribes being quicker and cheaper than legal fees fighting in slow Belgian courts for many years. But when poor people cannot pay the bribes, the EU Commission and Belgium join in efforts to murder the witnesses and victims, by depriving them of health care until they are possibly dead. I am one of the multiple victims of this bribery-extortion-murder scheme.

Psychopath and racist Swedish criminal Tina Nilsson of the EU Ombudsman - writing vicious and brutal lies about EU law, and about the crimes of her good friends at the EU Commission - is one of the leading people seeking to murder EU citizens who are not paying bribes to the friends of corrupt EU Commissioner for Justice Didier Reynders. Nilsson is ready to murder anyone, and won't hesitate to tell her friends with links to NATO, about which Swedish officials might need to be murdered to help cover up her crimes.

The reason that the EU Commission and EU Ombudsman are so active in bribery and extortion with gangster partners in Belgian government, is partly the massive personal corruption of Ursula von der Leyen - with millions for example, relating to Ursula's husband Heiko in the covid vaccine business, and now a new wave of corruption relating to the Ukraine conflict - but also, the fatal flaw in the EU structure, enabling EU Commission leaders and staff to escape prosecution for crimes, by entering into a crime partnership with Belgium.

With Belgium having criminal jurisdiction over crimes committed in Belgian EU offices, a natural relationship has developed between the EU's dominant Germans and the Belgian hosts of the EU. This now has become a full mafia partnership in crime and murder, with the corrupt Von der Leyen Commission since 2019, and the equally corrupt De Croo government since 2020.

Corruption-focused Von der Leyen quickly grasped her opportunity to steal millions for her family, so long as she bribed the Belgians to join her as partners in crime, the link of course being her gangster EU Commissioner for Justice Didier Reynders, now in the 2nd major bribery scandal of his career (the earlier one became suddenly 'closed' under Belgian 'justice'). Reynders is a political party group partner of nearly one-third of the current Belgian government. The EU-Belgian scheme demanding bribes for EU citizen access to health care, may be one of only a number of crime schemes going on between the EU and Belgium.

Another aspect of Von der Leyen crime, is her deep connection to NATO and the \$65 billion in revenues and profits already spent in the Ukraine conflict. Von der Leyen is able to terrorise others - including your Swedish government - that she has 'friends in NATO and intelligence services' who can kill people ... 'so maybe you should keep your mouth shut about Von der Leyen corruption'.

With her triple weapons of bribery cash to share, threats of murder thanks to her NATO friends, and severe harm to civil servant careers for anyone who doesn't play along, Von der Leyen quickly swept through all four of the EU ethics and prosecution bodies, and got

everyone 'on board' with her corruption, through bribery or intimidation or some combination of these.

The EU Ombudsman including Swedish criminal Tina Nilsson, under her corrupt Irish boss, Emily O'Reilly; the EU Commission Ethics Secretariat under Latvia's corrupt Ilze Juhansone; and the EU OLAF anti-fraud prosecutors under Finland's Ville Itälä, all quickly write stupid lies about any crimes involving Von der Leyen, Reynders, or Belgian officials violating EU law. And Romanian Laura Kövesi, heading the EPPO European Prosecutor in Luxembourg, holds back, not saying anything, refusing to help victims, seeing all the crimes with the EU Commission and Belgium, but apparently afraid of a knife in her belly or a bullet in her head.

So the 'ethics' and 'anti-corruption' bodies within the EU, all became a fraud and a joke and do not function at all, against a corrupt EU Commission President and leadership such as now under Von der Leyen. Hive-minded EU civil servants are often seduced by their lush salaries & pensions, to a point they have the ethics of guards at a genocidal extermination camp: 'If the boss wants to break laws and kill people, of course I do what the boss wants.'

There are of course honest EU Commission employees at middle and lower levels, and some of them have been friends of mine for many years, giving me information in this struggle. But honest EU Commission staff are terrorised with threats of career damage and murder if they do not keep their mouths shut. And it is the criminal psychopaths who rise to the top - For example, Spanish criminal Ana Gallego, was recently promoted to head of DG Justice under Reynders, after proving she was willing to tell lies and murder innocent people.

All in the EU is drowned in corruption by Ursula von der Leyen's bribery of the Belgian government, which has prosecutor jurisdiction over EU offices. Von der Leyen allows Belgium to violate all EU laws ... Belgium does not prosecute or investigate Von der Leyen. A perfect corruption circle.

And to note re 'Qatargate', the prosecution of EU Parliament Members by Belgian police and prosecutors. In case you in Sweden do not know, 'Qatargate' is an initiative of NATO-linked intelligence agencies, to discredit the EU Parliament as a whole, given that its 700-odd members tend to include 100 or more 'rogue' voices denouncing corruption, war-mongering, etc. This is actually a NATO attack on EU democracy, an effort to shut down dissident voices.

Qataris were observed making more 'direct' payments, than the more indirect 'legal bribery' e.g., Soros foundations via NGOs paying MEPs for 'services' etc. Qataris were allowed to continue until a major attack was launched discrediting the EU Parliament as a whole, to defang its influence (particular MEPs entrapped were not important to this function). 'Qatargate' also lets Belgium and the EU boast of being 'anti-corruption', when in fact corrupt Belgium is the EU's biggest violator of the Rule of Law and EU Citizen Rights, and corruption at the EU Commission is far worse and far more dangerous than at the EU Parliament.

Ursula Von der Leyen had a history of some scandal taint before going into her present position as EU Commission President. But Von der Leyen's incompetence and stupidity, and her pose as aristocratic female, made her seem a good choice for her German and American handlers, someone who would do what she was told and serve any crime, no matter how unethical or murderous. And now we see a Von der Leyen who is committing enormous crimes against EU citizens.

As a big start to her corruption saga whilst President of the European Commission, is Von der Leyen's lack of ethics and conflict of interest whilst trying to enrich her husband Heiko, out of the \$195 billion covid vaccine industry in which Heiko is a profit-seeking player. This is well known across Europe, embodied in this popular meme about her corruption which will point you to details that should be investigated, but aren't, thanks to the Von der Leyen - Belgium corruption agreement, and Von der Leyen's swift suborning of all EU Institution ethics and prosecutor bodies:

Conflict of interest at the top of the EU?

Pfizer is of course on public record as being involved in some of the biggest bribery scandals in history. It is commonly understood that Von der Leyen's husband Heiko is perhaps already receiving EU vaccine contract funds via some opaque long chain of sub-contracts, or that he will begin doing so after Von der Leyen leaves the Commission.

The covid vaccine funds corruption also makes Ursula and Heiko von der Leyen, the 'business partners' of Belgium's notorious gangster Health Minister Frank Vandenbroucke, himself widely regarded as a recipient of bribes, easily delivered from Pfizer's factory in Belgium. Frank Vandenbroucke is supervising the Belgian side of the criminal scheme demanding

bribes from EU citizens before they can enjoy EU Citizen Rights to health care. This is the second major bribery scandal both for Frank Vandembroucke and for his friend and partner, EU Commissioner Didier Reynders.

In his earlier bribery scandal in the 1990s, Agusta-Dassault, where Vandembroucke induced laughter with an amusing tale of 'burning the bribery cash so it wasn't spent, so no harm done', Vandembroucke is also linked to a terrorist murder, still in part unsolved. It is widely thought in Belgium that Frank Vandembroucke has friends who can still murder people, and this is a basis of political terror here in Belgium, with people in Belgium being told that we can end up like this man here, Belgium politician André Cools, murdered before he could reveal more of what he knew about Belgian corruption. More than one Belgian has told me that this below may be my fate, for daring to expose the corruption of Frank Vandembroucke, Didier Reynders and Ursula von der Leyen:



The EU law being violated by Frank Vandembroucke, Ursula von der Leyen, and their criminal subordinates such as Swedish gangster Tina Nilsson, is so crystal-clear that they have to resort to extremely obvious criminal lying to conduct themselves.

The core law - which every single one of the EU Commission and Ombudsman gangsters avoid discussing, is EU Court Order C-535/19 of 15 July 2021. This CJEU Court Order makes it clear that the right to enroll in a national health care system wherever in the EU an EU citizen is resident, is inviolable, an intrinsic part of EU treaty rights of Freedom of Movement:

As Swedish Minister for Health Care Acko Johansson can verify, an EU nation MUST enroll a legally-registered EU Citizen resident into the national health care system, if no other EU-approved health system covers that person (such as the one for EU Institution staff members, or coverage from cross-border employment). It is completely forbidden to deny access

because people are without jobs, as pensioners or partners of others etc. It is completely illegal to exclude registered EU citizens from an EU member state health care system, on the basis of national laws or restrictions, although richer individuals can be required to pay a fee.

EU Court Order C-535/19 has been the subject of publication by expert Prof. Santa Slokenberga of Uppsala University, who is aware of the criminal situation going on in the EU and in Belgium. You may wish to consult with her as part of prosecuting these crimes.

There is a visible psychopathic pleasure by Swedish criminal Tina Nilsson, her crime friends at the Ombudsman and EU Commission, and their crime partners in Belgium, in violating EU law directly and blatantly. One of the clearest aspects of EU Court Order C-535/19, is that it is absolutely, totally illegal to deny access to health care systems, because someone is 'economically inactive', not having a job in his EU country of residence (pensioner, supported by romantic partner, etc). This is known in every law faculty in the entire European Union, as Prof. Slokenberga at Uppsala can confirm. Yet this is the exact reason used by the EU-Belgium extortion network to deny me health care, after I refused to pay bribes to them!

## Court of Justice confirms economically inactive EU citizens have right to be affiliated to health insurance system of another Member State

In order to violate this crystal-clear law and seek bribes from EU citizens registering in Belgium, corrupt Belgian civil servants under gangster Belgian Health Minister Frank Vandenbroucke, create many months of delays for fictitious and bizarre reasons, seeking a bribe to 'fix the problem' and allow the EU citizen to have health care. Then they tell lies about EU and Belgian law, pretending ancient Belgian laws are still valid when in fact they are

null and void. They have no shame about asking for a bribe in writing by e-mail, telling me I can get my EU Citizen Rights more quickly if I hire one of them as my 'personal consultant'.

And given that their whole scheme of seeking bribes is quite racist, targeting the foreigner, the Jew, the Muslim, Belgians had no hesitation of telling me I am a '2nd class' sort of EU citizen, not having rights like the powerful Germans and Belgians at the core of this 4th German Reich EU mafia.

This racism was fully endorsed at the EU Commission, where the 11 criminal individuals attacking me are all Western or Northern Europeans, none of them a '2nd class' Slavic or Eastern EU individual like myself. Swedish criminal Tina Nilsson, with her leading role in murdering me, has no problem seeking to murder a whole string of 'Untermenschen'.

For EU Ombudsman gangster Tina Nilsson, her attitude is that, 'I am powerful northern Germanic woman like Von der Leyen. If Muslim family cannot afford to pay bribes to Didier Reynders' friends, of course I am happy to kill a Muslim woman, deny her health care, destroy her family. Jew doesn't want to pay bribes with his secret Jew money? My boss says kill the Jew, von der Leyen says kill the Jew, of course I want to kill the Jew too! I feel powerful when I write lies that help kill people, this is good for my boss & my career!'

Everyone at the EU Commission and EU Ombudsman and in the EU bureaucracy, refuses to enter into discussion of EU Court Order C-535/19, because this discussion exposes them all as criminals. They know that almost instantly, they can get a defining ruling via their special request line that the EU Commission and Member States all have, at the EU Courts in Luxembourg ... but as criminals, they do not want to hear the Court's clear words.

With victims, this starts in Belgium. Belgian civil servants refuse to answer questions about EU Court Order C-535/19, or tell stupid lies about what the law says, or tell the criminal lie that EU law is 'doubtful and uncertain' and must 'undergo study', for a period of many years ... this lie hiding how EU Member States have special quick access to EU Courts in Luxembourg, for a swift ruling explaining anything 'doubtful and unclear'.

Another side of the Belgian-EU extortion game is weaponising the slow Belgian courts, where cases can take 20 years to be resolved. The Belgian officials asking for bribes by e-mail, openly taunt victims with admissions that, 'Yes, you can win your rights in court ... but maybe you will be dead before you win, haha! We have unlimited thousands to spend on gangster lawyers, happy to try to murder you and delay your rights for many years. And we can get our bribes in kickbacks from those lawyers, if you don't want to pay us. Don't want to pay a bribe? Dare to file a complaint? Haha, you stupid victim, then it is total war ... and Didier Reynders at the EU Commission, and Ursula von der Leyen, will help us to murder you.'

Belgian federal police and their official EU-linked anti-corruption unit, are well aware of all these crimes ... but the De Croo government has cut their budget, media reporting how the federal police budget is for 'crimes by Muslims' ... not for crimes under Belgian ministers.

The Belgian side of the EU-Belgian bribery extortion scheme is fully described in this 28-page dossier filed with EU Rule of Law Commissioner Věra Jourová, fully exposing that Belgium is in fact the worst country violator of 'Rule of Law' in the entire European Union:

But Commissioner Jourová, never dared to reply to this dossier, under personal order from Ursula von der Leyen, decreeing that violations of EU law in Belgium, are to be ONLY handled by Belgian EU Commissioner for Justice Didier Reynders ... who then would of course 'fix' things for his Belgian government friends. Jourová and the EU Czech Presidency totally knelt and submitted to the EU-Belgian corruption mafia, taking the view that it is just 'too dangerous' to fight this German 4th Reich EU crime network using Belgians as their top thugs.

This is a total corruption circle, with Reynders' own MR-OpenVLD party grouping including not only nearly a third of the Belgian government cabinet, and even Belgian Premier De Croo and Belgian Justice Minister Van Quickenborne ... but also including no less than EU Council President Charles Michel, who has been the perfect gangster abettor of all these crimes, claiming he 'can't be involved' in crimes going on in Belgium and at the EU Commission, crimes involving so many of Michel's political partners. And now of course in July 2023 the Belgian EU Council Presidency begins, for a truly total EU corruption experience.

The EU Commission and Ombudsman bribery-extortion-murder crime gang

In the crime scheme of bribery extortion that the EU Commission and Belgium operate over EU Citizen Rights to health care, I document a full 11 criminal individuals at the EU Commission and Ombudsman, 7 of whom have sent me written communications of falsehood, which constitute criminal terrorist attempts to murder me by depriving me of health care.

The worst and biggest liar amongst all these criminals, in the criminally incriminating documents transmitted to me, is Tina Nilsson of the EU Ombudsman. Overall, there are a larger number of civil servants at the EU Commission and Ombudsman who committed public criminal acts in seeking to murder me, than in the Belgian civil service which initiated the bribery extortion against me.

One of the 7 EU Institution gangsters spitting lies into my face whilst seeking to have me murdered, is no less than Ursula Von der Leyen's top EU Commission lawyer, Daniel Calleja-Crespo, Director-General of the EU Commission External Legal Service. Although he spews criminal insults at me, Calleja-Crespo does not even try to deny that Von der Leyen & Reynders operate a bribery-extortion terrorist scheme out of EU Commission offices. He doesn't defend Von der Leyen's honour, knowing she is a criminal with no honour to defend.

Calleja-Crespo seems to be encouraging me to file an EU Court action against the EU Commission, which gives him a chance to collect bribes from law firms to whom he issues hundreds of thousands of euros' worth of 'legal defence' contracts. Here is Calleja-Crespo being informed about the bribery extortion scheme run out of EU offices:

This form of corruption - breaking laws on purpose, so civil servants can then receive kickback bribes from law firms employed to argue the case - is a central aspect of this whole EU-Belgium bribery scheme. If the citizen doesn't pay the bribe, the civil servants in Belgium and also at the EU, can then get bribes from the law firms hired to harass the citizen and delay his rights until he is perhaps dead.



A notable fact about the criminals at the Commission involved in this scheme of bribery extortion and murder, is that the very top supervisors shy away from putting their names onto criminally incriminating documents, although clearly ordering their subordinates to write lies and attempt to murder witnesses and victims.

Belgian EU Commissioner Reynders does not personally sign his name to the documents telling lies and attempting to murder me, but his top underlings do so for him. These criminals putting themselves in line to go to prison, are two women - the German Monika Mosshammer, said to be the 'German sister' of Ursula von der Leyen, in carrying out crimes for her; and Spanish Ana Gallego, recently promoted to Director-General of DG Justice after proving her ability to be a racist, violate EU laws, and murder innocent people. The communications of both of these women have a nervous tone signalling criminal guilt.

And then in another EU Commission gang of prostitutes for Von der Leyen, the EU Ethics Secretariat, head by the EU's top civil servant, Latvian Ilze Juhansone - Juhansone refuses to personally sign her name to the criminally incriminating documents she instructs, but instructed her lackey, the German Christian Linder, to put himself in line for prison.

The same criminal pattern is there at the EU Ombudsman, whose top official, Irish Emily O'Reilly, gives the orders to tell lies and murder people, but won't sign her name to anything, and instead has her sadistic Swedish criminal Tina Nilsson be a criminal on her way to prison, with additional written confirming support from another Irish criminal, Rosita Hickey.

At the utterly unprofessional OLAF anti-prosecutor office, Finnish gangster Ville Itälä hides behind anonymous e-mails signed by nobody. As soon as he receives any information about crimes involving Von der Leyen, Reynders or their friends, he rockets back anonymous e-mails with lies claiming he has no jurisdiction over huge fraud and extortion crimes run out of EU offices by these people. As noted above, Romanian EPPO chief prosecutor Laura Kövesi in Luxembourg, declined to say anything at all once the scale of these crimes became clear.

And at the top of the corruption chain, is Ursula von der Leyen, giving orders to try and murder EU citizens who are witnesses to her corruption empire, but not signing anything. Her top EU Commission lawyer, Daniel Calleja-Crespo, is cagey enough to deny huge crimes are taking place ... but still can't restrain himself from e-mailing stupid lies to abuse and libel the victim he supervises trying to murder. Calleja-Crespo seems eager for kickback bribes from law firms to whom he will give contracts, after an EU high court case is filed against the EU Commission for these crimes.

So amongst these 11 EU Institution criminals actively seeking my murder in revenge for my being a witness to EU corruption, we have

- 3 Germans, Von der Leyen, Mosshammer, & Linder
- 3 Northerners, Swede Nilsson; Finn Itälä; & Latvian Juhansone
- 2 Spaniards, Calleja-Crespo & Gallego
- 2 Irish, O'Reilly & Hickey
- 1 Belgian, tho at the top, Reynders

All of the above gleefully joined in seeking the violation of human rights, extortion and murder, of a '2nd class' EU citizen from Slavic Poland.

The EU Commission role in the Belgian bribery-extortion crimes of Commissioner Reynders' friends in Belgian government, has been going for nearly a year and a half now. In January 2021, I rather naively approached Didier Reynders office, asking him to please informally intervene and tell the gangsters in Belgian government to stop being such egregious violators of EU law and EU Citizen Rights.

For many years I have known and been friendly with EU Commission staff members, some of them at the Commission at present. But they are however only at mid-level, not at the upper level of criminal psychopaths which now dominate the EU Commission of Von der Leyen and Reynders. For my friends as well as myself, this battle to save my own life and the life of others, has been quite an education in the criminal rot at the top of the Von der Leyen Commission.

One element apparently, is that Von der Leyen uses the 'women power' sales pitch, to enlist other females of the EU Commission and Ombudsman into her crime network. (Note that of the 11 named criminals at the EU Institutions seeking to murder me, 7 of them are women.) Von der Leyen apparently is quite skilled at convincing other women to enjoy being part of corruption, stealing millions of euros, violating laws, denying human rights, and murdering innocent people. They feed each other's arrogance after being suborned by Von der Leyen.

Von der Leyen plays on the psychology of, 'We women are a TEAM, we are very powerful together, no one can question what we do!' At the same time there is an element of terror and fear, Von der Leyen both hinting at how her NATO intel agency friends can kill people, and how there is danger for the career of anyone opposing her. It is just as with drug dealers, '*plata o plomo*', 'silver or lead', the bribe or the bullet, you are part of my corruption or I destroy you ... and it seems Von der Leyen easily 'flips' women into joining her criminal network, given that 'you know all Germany and all of NATO is backing me!'

In early 2021, there was a reply to me from Reynders' close aide - Von der Leyen's 'German sister' Monika Mosshammer - relaying a false picture of EU law, claiming EU countries could do what they wanted regarding health care rights, and asking me for more information re Belgium. I replied instantly, correcting Mosshammer on the true nature of EU law, and showing her the full documentary proof of Belgian government systematic violation of EU Court Order C-535/19. Mosshammer then refused to reply to all communications from me for 9 months.

In the meantime, amongst many other actions - such as asking and then receiving kind King Philippe of Belgium intervening on my behalf, only to have the King be insulted and rebuffed by the criminally corrupt Belgian De Croo regime - I prepared and filed a full formal Rule of Law complaint with Czech EU Commissioner for Rule of Law Věra Jourová and the Czech EU Presidency - to which Jourová and the Czechs, under orders from Von der Leyen, never replied:

With pressure from several sources for a reply from the Commission, I then received a letter with a truly stupid huge lie from Reynders' aide Mosshammer, telling me that I 'never sent her information on the reason cited by Belgium denying my rights'. Mosshammer's letter, however, included various 'Ares' numbers used to track EU communications, and these

numbers were proof Mosshammer was lying, as those communications documented that in fact Mosshammer HAD RECEIVED the evidence, of which I then reminded her.

In classic over-the-top lying, Mosshammer then falsely claimed that 'all issues had been addressed' in her previous two e-mails ... and that anything further would be 'repetitive', so nothing whatsoever would ever be done by the Commission about the violation of my rights by Reynders' friends in Belgium ... so it was 'case closed' and I should just suffer and die without health care.

Like many others, Mosshammer totally refused to discuss EU Court Order C-535/19 on universal EU Citizen Health Care Rights, and the proof the Commission holds of systematic violations of EU law by Belgium.

Mosshammer was using a top favourite EU Commission evasion technique for EU Commission criminal activity ... two dishonest lying evasive e-mails are sent to you, never addressing the main issue, and then there is a lying claim that this is a 'full response', anything else is 'repetitive', and therefore 'no other communications from you will be answered'. - 'The decision has been to try and murder you by depriving you of health care, so shut up and suffer and die, you stupid helpless EU citizen.' And of course after you expose their lies, they libel you as being 'abusive'.

Following the EU 'ethics' and 'prosecutor' complaint procedures, I came to hold the proof of how Von der Leyen had swept through all four EU ethics & prosecutor bodies, and captured all of them for her criminal purposes, with her ample resources of intimidation and bribery.

And the biggest, most brazen criminal of all of them putting lies into writing, was Tina Nilsson of the EU Ombudsman office. She repeated Mosshammer's whopping lies about EU Health Care law and endorsed them, claiming countries could deny people health care by any 'rules' of their own. And of course Nilsson totally refused to discuss EU Court Order C-535/19 and the proof of its violation in EU hands. And she totally refused to discuss the proof Mosshammer was a whopping huge liar. 'No manifest error of assessment,' said the racist and murderous Nilsson, enjoying being the neo-Nazi Swede seeking the terrorist murder of her Polish citizen victim, as part of the Von der Leyen 4th Reich.

With extreme pleasure in egregious falsehood, Nilsson declared there was 'no conflict of interest' in Belgian Commissioner Didier Reynders being the one to deny EU Citizen Rights to victims of Reynders' own political party colleagues engaged in bribery, extortion, and systematic violations of EU law ... violations clearly being conducted against a large series of victims, whilst Nilsson wrote lies denying this.

In my long struggle, now over two years long, trying to ensure I am the last and final victim of this EU-Belgian corruption complex, nothing surprises me anymore. The Czechs did not have the courage to say a word about these crimes, and Von der Leyen will expecting Sweden to fail in the same way. I hope you can surprise me as I ask for Sweden's protection against a Swedish terrorist and murderer. Many people expect me to be killed or die, and maybe that is what will happen.
