**Misconduct of EU Commission President Ursula von der Leyen**

**Personal Conflict of Interest & Hatreds, Denial of Polish EU Citizen Treaty Rights**

**Collusion with Belgian Commissioner Reynders, when Belgium is EU Law Violator**

Dear EU Ombudsman O'Reilly,

You now have before you a case of EU Commission administrative misconduct, where the facts and EU Law are simple, but where the persons involved are perhaps the most terrifying you have faced in your near-decade as Ombudsman since 2013.

The principal wrongdoer I am asking you to address, is EU Commission President Ursula von der Leyen. In personal conflict of interest, Von der Leyen is blocking and impeding honest EU Commissioners and staff from acting in defence of my crystal-clear EU Citizen Rights under EU Law, which are being illegally blocked in Belgium where I am resident, by personal friends of EU Commissioner Didier Reynders involved in bribe-seeking.

Von der Leyen has joined her own conflict of interest to the conflicts of interest of Commissioner Reynders, and is personally giving Reynders the power to unethically control the EU Commission dossier on Rule of Law crimes by Belgium against me.

Although fully informed and aware of the conflicts of interest of both Reynders and herself, Von der Leyen is refusing to transfer this dossier out of the corrupt hands of Reynders, and she is not permitting honest, unbiased EU Commissioners and staff to act to defend my EU citizen rights.

This, very specifically, is what I am asking you to do, Ms Ombudsman - confront Von der Leyen over her blocking my dossier, from being handled by an honest Commissioner, someone other than the grossly conflicted corrupted Reynders.

Resident in Belgium, I am a Polish citizen, a pensioner from a 3rd country, and thus 'not economically active', placing me in the category category of Art. 11(3)(e) of EU Directive 883 /2004, regarding Rights of enrollment in EU national health care systems.

As no one at the Commission even tries to deny - and as EU Health Commissioner Kyriakides can verify for you if you have any questions - I have absolute, immediate rights to enroll in the Belgian National Health system, this Right clarified with perfection and simplicity by EU Court Order C-535/19 of 15 July 2021, especially Articles 50, 59, 63, 65.

DG Health has ordered Belgium to comply with this court order ... but corrupt Belgian officials, encouraged by Commissioner Reynders, are directly defying EU law after I refused to pay them bribes for my EU Citizen Rights. They mistakenly saw me as a 'rich Jew who can easily afford to pay'.

If you take a few minutes to read those four Articles in EU Court order C-535, you will understand the EU law here clearly. The EU court declared that -

- It is an intrinsic part of Freedom of Movement, to enroll in the National Health System where an EU Citizen is legally resident, where no other EU system is covering the citizen (e.g., your own JSIS system for EU staff, cross-border employment);
- It is absolutely FORBIDDEN and ILLEGAL to deny EU National Health System Access, on the grounds that the EU citizen is 'economically inactive', such as myself.

Although obviously entirely illegal under EU law, this 'you are economically inactive, and so we deny you' was the final reason the Belgians used to deny my health care enrollment, in a 13 January 2022 letter they sent, after I refused to pay the bribes they had discussed with me by e-mail.

Belgium now suffers under a Health Minister, Frank Vandenbroucke who was infamous for involvement in bribery back in the 1990s, the Agusta-Dassault scandal, linking as well to a political terrorist murder. Vandenbroucke now oversees a bribery-extortion operation targeting some of us EU citizens, blocking our access to the Belgian Health System unless we pay bribes, which most victims seem to pay.

'Cheaper than lawyers and much faster than slow Belgian courts', is their persuasive sales tool. They even tell you in writing that you can win in court - but it will take years, and they hint they get bribes from the lawyers hired by the Belgian government to harass victims and delay our rights.

Tactics of Belgian officials include inventing bizarre reasons for delay, hiding EU law, refusing to answer questions about EU law, and eventually just writing the stupid lie that EU law is 'doubtful and unclear' if you don't pay a bribe, and they will need to 'study it' for many years into the future, until after you are dead or leave Belgium.

This scheme is supported by Belgium's De Croo government, De Croo restricting the Belgian federal police budget so crimes against me could not be prosecuted. The King of Belgium tried to help me, but was insulted by the De Croo regime, Belgians apparently knowing that Reynders would be corrupt in assisting them at the EU Commission.

This scheme has been known in EU Commission offices since January 2022, the dossier illegally commandeered in a hostile, unethical, illegal manner, by Didier Reynders and his corrupt, now-proven-to-be-a-liar assistant, Monika Mosshammer.

The full dossier on the Rule of Law crimes by Belgium against me, with all details and proof documents of the Belgian officials incriminating themselves - in its final, exhaustive, 28-page form, was filed with EU Commissioner Věra Jourová in October. And then, for the misconduct of conflicted-in-interest Commissioner Reynders and Monika Mosshammer, violating multiple provisions of the EU Commissioner Code of Conduct and the EU Code of Good Administrative Behaviour, the 8-page detailed November complaint against them with the EU Secretariat, is both attached, and

Very briefly, how Reynders & Mosshammer 'handled' my dossier about violations of EU Law by Reynders' friends and fellow political party members, was this:

- In February Mosshammer sent me an evasive letter not addressing what I had written her, and asking for more evidence, which I promptly supplied to her.
- Mosshammer then refused to answer all communications from me for over 9 months.
- Finally, in November, after my filing with Commissioner Jourová, and after Reynders was pressured by EU Parliament members, Mosshammer sent a bizarre note to me with the falsehood that I had never supplied her with information about what reason Belgium had used to deny my rights; this was immediately proven a falsehood, by the documents Mosshammer herself admitted she received.
- Shamed by being exposed as someone inserting false statements and lies into EC files, Mosshammer then sent me a brutal, gloating note, telling me that all discussion with me was terminated, the Commission would never again respond to me, and nothing would ever be done about the crystal-clear violating of my EU Citizen Rights by Belgium, which she refused to discuss in any way.

It is of course the clear written duty of EU Commission President Von der Leyen, when an EU Commissioner is in conflict of interest on a matter, to remove that matter from his control, and give to another Commissioner. And in fact, several other Commissioners are quite ready and capable to receive my dossier and act upon it:

- Rule of Law Commissioner Jourová who received my full dossier in October;
- Health Commissioner Kyriakides who has full expertise on my EU Citizen National Health System Access rights under EU Law and especially EU Court Order C-535/19;
- Equality Commissioner Dalli, who likewise can act in this scheme of Belgium's racist unequal targeting of non-Belgian EU Citizens for bribery and extortion.

EU Commission President Von der Leyen and her team, have been kept informed about these shocking events in Belgium for some time. When I made my Ethics Violations filing with the EU Secretariat on 20 November, I served a letter than same day upon Von der Leyen and her staff (attached), reminding Von der Leyen of her strict, clear duty, and how she MUST act to remove the dossier on my EU Citizen Rights, out of the hands of the corrupt Reynders. Emphasising the importance of her obligations, I sent sms messages to the telephones of 9 members of Von der Leyen's personal team of press agents, speech-writers and assistants, leaving no doubt she received my messages.

Von der Leyen and all her team have refused to reply, and the reasons are quite shocking. My understanding is that Von der Leyen has apparently developed a great personal hate for me, for several reasons. Von der Leyen wants me to suffer and have my life destroyed via having my EU Citizen Rights denied. Below are the reasons why.

One is that Ursula von der Leyen's husband Heiko is in the covid vaccine business, and von der Leyen is apparently known across the Commission and across Europe, for mis-using her position to turn some of the billions in EU funds devoted to covid vaccines, into millions for her husband herself. As part of doing vaccine-marketing for her husband, Von der Leyen sees herself as a 'business partner' of the Belgian Health Minister Frank Vandenbroucke, who oversees the bribery-extortion scheme against me, a Minister who hates me for exposing his corruption.

Belgian Minister Frank Vandenbrouck is a notorious vaccine-pusher, and is widely understood to be 'probably' in a bribery-relationship with Von der Leyen's friends at Pfizer ... who are possibly paying Heiko von der Leyen via an opaque chain of subcontracts to Heiko's company, out of the funds Von der Leyen awarded to Pfizer. Frank Vandenbroucke is infamous for taking bribes - here is a video of him talking about receiving bribery cash in the 1990s, and allegedly 'burning' it so it 'wasn't spent' LOL.

And Pfizer is infamous for paying bribes, having paid some of the largest fines for bribery corruption in history. Pfizer has a factory in Belgium, cash bribes easily delivered here.

A second reason Von der Leyen hates me and wants to use her position to damage my life as much possible - maybe even succeed in killing me by illegally blocking me from health care - is that I have exposed the racism, corruption and hypocrisy of the attacks on Poland and Hungary over 'Rule of Law' issues ... attacks being co-led with Von der Leyen, by the corrupt, bribery-extortion-involved Didier Reynders!

As I noted in my October filing with Commissioner Jourová, there is nothing in the complaints the EU Commission has regarding Poland and Hungary, anywhere near as serious as the corruption issues in Belgium, these Belgians conducting bribery and extortion over core EU Citizen Treaty Rights.

Ursula von der Leyen absolutely hates what I have exposed, as obviously neither she nor Reynders actually cares at all about 'EU Law' ... the 'Rule of Law' complaints being somewhat just domination games, the northwest European 'elites' against the '2nd class EU countries like Poland or Hungary or Italy'.

There is at core, a terrible racism about both Commission President Von der Leyen and Commissioner Reynders - their attitude is 'We are Germans and Belgians, we can violate all EU Law and EU Court Orders, we can totally violate EU Ethics Codes, we can be corrupt, and all those 2nd class EU countries and citizens should keep their mouth shut.'

Yet a 3rd reason for Von der Leyen hating me and wanting to destroy my life, is that Commissioner Reynders' dishonest and sadistic German assistant Monika Mosshammer, is apparently a friend of Von der Leyen, and 'we German women need to stick together'.

The 4th reason for Von der Leyen to have sadistic hate for me, as I understand from EU staff members - I have known some EU Commission staff for many, many years - is that

there is in essence, a 'corruption understanding' between the EU Commission elite and the Belgian government, that they cover for each other's crimes.

It is apparently important to Von der Leyen, that Belgium be unwilling to prosecute criminal acts by top EU Commissioner members and their friends, when they commit crimes on Belgian territory. In return, the EU Commission gives Belgian government a 'free pass' on violations of EU law, even if that means engaging in bribery-extortion by Belgian officials against EU citizens such as myself.

Well, Ms EU Ombudsman O'Reilly, there you have it ... you know what you SHOULD do, but the question I suppose is, how much fear do you have of these people? Von der Leyen is known by EC staff as utterly corrupt, vengeful, the worst EU Commission President since the 1990s Santer-era scandals. EU staff will breathe easier when Von der Leyen is gone.

Commissioners Jourová and Dombrovskis are having a difficult time with what they've learned, as they have been on the front edge of the EU Commission jabbing at Poland and Hungary over 'Rule of Law' ... and now they know that the biggest 'Rule of Law' violators in the EU are the government of Belgium, Commissioner Reynders, and vaccine-saleslady Ursula von der Leyen.

Von der Leyen perhaps assumes, Ms Ombudsman O'Reilly, that you will be terrorised into joining in her vicious hate, her abuse of power to deny human and EU citizen rights to a Polish citizen.
